2013 Glocal Impact Conference RELEASE AND WAIVER OF LIABILITY

I, and My Child/children or the child/children under my legal guardianship identified in the event registration form ("My Child") desire to participate in the River of Life Christian Church's Glocal Impact Conference, from Thursday, August 1st to Sunday, August 4th, 2013 ("Event") organized by the River of Life Christian Church and its affiliates ("ROLCC"). ROLCC conducts all of its Event activities on the premises located at 1177 Laurelwood Road, Santa Clara, California ("Premise") and at Santa Clara Convention Center on 5001 Great America Parkway, Santa Clara, California ("Convention Center").

In consideration for permitting me and My Child to use the facilities, services, and programs of the Event, and for the participation of us in such programs, and intending to be legally bound for myself, My Child, my heirs, representatives, executors, administrators, successors, and assigns, I hereby agree and represent as follows:

1. Me and My Child shall comply with all oral and/or written rules, instructions and directions communicated by ROLCC in connection to the Event, its facilities, services, activities, and programs ("Event Rules"). Failure to observe the Event Rules may result in the immediate removal of me and My Child from the Premise and the Convention Center, and/or the prohibition of me and My Child's participation in the Event. Should the violation of the Event Rules also result in bodily injury or property damage, I will be responsible and pay to the injured party for all damages resulting from my and/or My Child's violation.
2. I also consent to My Child's participation in all Event activities on the Premise and the Convention Center. This authorization extends to all outdoor and indoor activities during the Event. This authorization also extends to My Child's use of materials and tools relating to Event activities, such as basic cooking tools, art materials, and building materials if any.
3. I hereby give permission to ROLCC to provide routine first aid care to me and My Child. I understand that ROLCC will make reasonable efforts to contact my emergency contact person as listed hereunder if I or My Child is injured or needs immediate medical attention. If the emergency contact person cannot be reached, then I give permission to ROLCC to seek emergency medical treatment for me and My Child, including the ordering of x-rays and routine tests. I also hereby authorize and give permission to the physician or facility selected by ROLCC to secure and administer treatment, including hospitalization, for me and My Child. I further give permission to ROLCC to arrange the transportation necessary for me and My Child to receive such medical treatment. I agree to the release of any records necessary for insurance purposes during the course of any medical treatment delivered to me and My Child.
4. I give permission to ROLCC to take photographs, audio recordings, and video recordings of me and My Child at the Event, and to use and publish such photographs, audio recordings, and video recordings containing my and/or My Child's likeness, including but not limited to my or My Child's body feature(s), and my or My Child's oral or written testimonial statement(s) given to ROLCC ("Personal Content") in conjunction with any article appearing on the ROLCC website or any other ROLCC publications, including without limitation brochures, fliers, print ads, and other media. I understand that me and My Child may be identified by name on such promotional materials without giving further consent to ROLCC.
5. I grant ROLCC to copyright the Personal Content and all work produced, created, or developed by me or My Child ("the Work") during the Event in the names of ROLCC, and to reuse, republish, display, broadcast and rebroadcast the Personal Content and the Work in whole or in part, individually, or in conjunction with printed matter, or in composite form, and in any medium now known or hereafter developed, for the purpose of publicity, public relations, promotion, advertising, media purposes and any other lawful purposes whatsoever.
6. **I HEREBY WAIVE ANY RIGHT TO INSPECT OR APPROVE ANY MATERIAL** that is used in connection with the Personal Content and the Work, and the **RELEASE AND DISCHARGE** ROLCC from any and all claims arising out of any ROLCC's use of the Personal Content and the Work for the purposes described above, including, but not limited to, any claims for libel and invasion of privacy.
7. **I HEREBY RELEASE, DISCHARGE, HOLD HARMLESS, AND COVENANT NOT TO SUE ROLCC**, its employees, directors, officers, staff members, volunteers, agents, successors, and assigns (collectively "Released Parties") from all liability for any loss or damage, and any claims or demands therefore, on account of injury to the person or property or injury resulting in death, whether caused by the negligence of the Released Parties or otherwise, while I and My Child are participating in the Event on the Premise and the Convention Center. This release extends to damages and injuries caused by hidden, latent, or obvious defects on the Premise and the Convention Center and/or relating to its equipment.
8. **I HEREBY ASSUME, ON BEHALF OF MYSELF AND MY CHILD, FULL RESPONSIBILITY FOR AND ALL RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE**, whether due to the active or passive negligence of Released Parties or otherwise, while I and My Child are participating in the Event on the Premise and the Convention Center, and/or using any facilities, tools, materials, or equipment thereon. This assumption of risk extends to damages and injuries caused by hidden, latent, or obvious defects on the Premise and the Convention Center or relating to its equipment.
9. I expressly agree that the releases and assumption of the risk set forth in paragraphs 6, 7 and 8, above, are intended to be as broad and inclusive as permitted by the law of the State of California. If any portion of this agreement is held to be invalid, then the balance of the agreement shall continue in full legal force and effect.
10. I am over the age of 18. **I HAVE READ AND AM VOLUNTARILY SIGNING** this Release and Waiver of Liability, specifically including paragraphs 6, 7 and 8, above. I am not relying on any oral statements outside of this agreement in determining whether to execute this document.
